Important Info: Please enter before closing date! **Ribbons:** To 8th place. **Class Fees:** Youth under age 18 - \$25 per class, adult - \$30 per class. <u>Classes combined or split as entries warrant</u>. Riders are encouraged to enter multiple classes to broaden their show experience. **Times:** When schedule is complete, it will be on website <u>www.southwindstables.com</u> Times will NOT be given over the phone. **Food**: good food will be available on grounds. **Facilities:** Show will be held on indoor sand ring. Large ring if weather permits; Intro & Training usually held in small ring. Large Ring is about 15 feet short. Outdoor small grass ring if needed. Outdoor <u>open</u> grassy areas to warm up. Sorry, no stalls available. <u>Please keep all show horses out of barn</u>. <u>Please leave dogs at home</u>. **Non-Compete horses** are welcome; must pay \$30 fee and sign all release forms. No horses on property without entry and release form.

Attire: <u>Mandatory Helmet</u>! Safe riding shoes with a heel, shirt with a collar, and neat appearance.

Entry Fees: Per class: Adults \$30; Youth \$25 (under 18 as of Jan 1) All Entries: Office Fee: \$20 per entry (each horse and rider combination is considered an entry; please use separate form for each). (There are no haul in or grounds fees) PLEASE REGISTER ANY NON COMPETING HORSE, \$30 grounds fee. Post Entry Fee-if entering after closing date, add \$10 per entry if fees are received after closing date (schedule permitting). Use of SWS Horse for SWS students: \$10 per class: List choice of horse (lessees get first choice).

Release: I/We make this entry at my own risk. I am aware that I will be riding in the open on grassy areas. I realize that horses are potentially dangerous animals and that simply being around them can cause injury and even death. I/We agree to hold harmless South Wind Stables, owners, lessees, and any officials, volunteers, staff, spectators, and any person connected with the show and barn from liability from any accident/injury. Everyone is urged to use caution and care while attending the show. It shall be a condition of entry that each exhibitor shall hold the Show, its directors, volunteers, and property owners harmless for loss or accident to his/her horse(s) or equipment which may occur. Notice: Under Ohio Law (ORC 2305.321) an equine professional is not liable for an injury to or the death of an equine activity participant that results from inherent risk of an equine activity. ***Also, as a participant, I will sign an additional release form the day of the show----under 18 must have parent or legal guardian present to sign for them***

"Inherent risk of an equine activity" means a danger or condition that is an integral part of an equine activity, including, but not limited to, any of the following: (a) The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine; (b) The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals; (c) Hazards, including, but not limited to, surface or subsurface conditions; (d) A collision with another equine, another animal, a person, or an object; (e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.
